# **Background**

Since the inception of the Apprenticeship Levy, the Salisbury Managed Procurement Services team at Salisbury NHS Foundation Trust have delivered a range of support for employers to increase their uptake of Apprenticeships. This provides a range of local, regional and national support services including the procurement of apprenticeship providers, the management of apprenticeship provider quality and engagement, and the contracting process, all of which have delivered considerable savings for employers in terms of reducing procurement cost, and also in launching a number of innovative delivery programmes for apprenticeships to support both small and large professions.

In addition to partnerships with NHS England and the NHS Leadership Academy, Salisbury frequently work in partnership with professional bodies, and NHS trusts, STPs / ICSs, and wider regional systems, as well as strategic organisations such as London Councils, the Association of Directors of Social Services, the Ambulance Chief Executives Association, UK Health Security Agency, and non health / social care bodies such as the Financial Conduct Authority.

Salisbury also partner with other organisations for the delivery of wider programmes, as well as working outside education in areas such as energy, professional services and commercial retail.

Salisbury NHS Foundation Trust are therefore a Contracting Authority within the meaning of the Public Contract Regulations 2015, and are able to make our procurements available to other public organisations listed in the relevant section of this document.

### **Our Commitment to Buying Organisations**

We operate a standard Service Level Matrix for both Buying Organisations (employers) and Suppliers as follows:

### **Procurement Levels and how to use**

Salisbury's Education Procurements work on two distinct levels – a general Apprenticeship framework, onto which any provider meeting the minimum criteria can list all the programmes they run. This is updated twice yearly for new providers to join, and for new standards to be added. Due to the way new standards are approved / released by Skills England, in some cases there will be a short delay between a standard being released for delivery, and provision showing on the Framework. Employers can either direct award via the Salisbury ordering / call off process, or Salisbury will run a further competition against the employers' criteria. Whilst we list the names of the training providers in the first part of this guide, due to the number of standards a separate Excel sheet is available from Salisbury detailing providers available by apprenticeship standard.

### **Higher Level Procurements**

Higher Level Procurements are where Salisbury have worked with partner organisations, such as NHS England or employer groups, to set a more stringent awarding criteria for providers. These are typically profession specific, have asked in depth questions about quality, delivery, and added value available to employers. These include national further competitions as well as regional procurements and those aimed at enabling provision for smaller professions. As with the general framework, employers can either direct award via Salisbury, or a further competition can be run against specific additional questions. Providers' bid responses for higher levels procurements are available from the FutureNHS Workspace.

Higher Level Procurements are listed in the second section of this guide, and should be referred to first before looking for providers for those standards on the main framework.

The NHS Leadership Academy - Salisbury work alongside the NHS Leadership Academy to enable the inclusion of various NHS LA programme content within apprenticeships. Programmes from these providers can be ordered in the normal way via Salisbury, however please ensure the content title (e.g. Mary Seacole) is listed in the "Pathways" section of the order form.

The <u>Apprenticeship Funding Rules</u> are set by the Education & Skills Funding Agency and vary according to the year of the apprentice's enrolment

<u>Ofsted Reports</u> for providers can be viewed on the Ofsted website, and you can set regular searches to be informed of changes to providers' status direct to your inbox

# **Accessing Providers**

Employers wishing to access providers should request Provider Contact details and original bid packs from Salisbury by emailing <a href="mailto:sft.commercial@nhs.net">sft.commercial@nhs.net</a>. Salisbury will then issue a URN Request form – this acts as the Order Form which the employer should complete and return to Salisbury, who will then issue the appropriate contract to the Provider. It is important that employers follow this process in order to be fully protected by NHS Contracts which include the Providers' bid responses and commitments, and to ensure compliance with both their internal procurement requirements and PCR2015. Providers are all told not to issue contract paperwork direct to employers, if they do this please return them and notify Salisbury. The call off / contracting flowchart is included at the end of this Guide. Employers can either direct award via the framework, run their own further competition, or Salisbury can run that process for employers using the employer's own selection criteria. Salisbury do not specify the criteria for direct awards.


- The URN (Framework Order) process is your protection that the correct and current contract is being used for your providers and gives you compliance with the Public Contract Regulations, and DHSC contract requirements for NHS organisations.
- Please complete the order form and send to Salisbury when you know the number of learners who will be enrolling
- This includes commitments to free resits / retakes, protection from penalty charges, and ensures providers' commitments on national procurements are included within the contract
- Salisbury will automatically check most current contract version is in place but cannot do that without a URN form for enrolments

#### **Framework Provider Selection Criteria**

In order to be accepted onto this Framework, providers have had to demonstrate / agree the following :

- Registration on the ESFA Apprenticeship Provider and Assessment Register,
- Where an Ofsted visit / full report has been issued, this must be Grade 1 or Grade 2 relating to both the overall outcome and apprenticeship delivery,
- Where an Ofsted Monitoring Visit / Report has been issued, this must show Significant Progress or Reasonable Progress across all reported areas, and cannot include any finding of Insufficient Progress or less for any delivery area,
- Organisations without an Ofsted visit / report must provide evidence of learner success rates above the national average for apprenticeships (across all courses).
- Must provide within the Levy funding band, one resit for every exam, assessment or module and one resit at EPA for each learner
- Must not require additional entry criteria to that listed in the Standard

Please note providers may be removed where their Ofsted rating subsequently falls below the above criteria.



### **Employer Provider Selection Criteria**

The framework allows for Direct Award by employers (buying organisations) in the following circumstances:

- The provider listed is the only provider on the framework offering the required Apprenticeship (based on provider's framework listing submissions), or the only provider already selected by a Higher Level (further competition) procurement and listed in that Profession Specific guide, or
- Where the employer requires face to face delivery, the provider is the only one on the framework listing the relevant Delivery Region, or
- Where the employer has a set reasonable travel distance for learners, the provider is the only provider on the framework meeting that distance criteria (which should be transparent and the rationale clear for selecting the distance), or
- Where the employer has selected a reasonable first threshold (for example, Ofsted rating
  or Apprenticeship Success rate), the provider is the only provider on the framework
  meeting that criteria. Such criteria must be transparent and may not be set so as to
  exclude or disadvantage other suppliers.
- The rationale for any direct award must be open and transparent, and must be within the Standing Financial Instructions / Procurement Rules of the buying organisation.

Where the above criteria are not met, a Further Competition will need to be conducted involving all providers on the framework who (a) meet the regional delivery requirements in which the buying organisation is based, and (b) all providers listing national delivery of the apprenticeship. This process can be supported / managed by Salisbury, and must be compliant with the Public Contract Regulations 2015, Section 33, Regulation 8(b).

# **Buying Organisation Reminder - Public Contract Regulations 2015**

Buying organisations and suppliers are reminded that at all times the liability for the selection decisions of the buying organisation rests with that organisation, and at no time shall Salisbury NHSFT be liable for any consequences arising from those decisions. Buying organisations must publish their award decisions within 30 days in line with the Public Contract Regulations 2015.

Guidance regarding award of contracts under framework agreements, as per the <u>Public Contract</u> Regulations 2015

- When the terms of a framework agreement are not precise enough to directly award a contract under Regulation 33(7) or 33(8)(a), the Buyer must run a further competition, as per Regulation 33(8)(b) or 33(8)(c).
- When the terms of a framework agreement are precise enough to directly award a contract, the Buyer must award the contract to the top ranked supplier in accordance with the assessment of award criteria when the framework agreement was established, or in accordance with any pre-prescribed rules (call-off protocol) regarding the use of catalogues, or reassessment of award criteria based on requirements configuration variations.

Procurement Act 2023 – Please note that as a Framework already "in flight" at the time of the
new Procurement Act, this Framework will continue under PCR 2015 as its legal regime, and
not the Procurement Act. If you are not ordering through the Framework, you must ensure
your provider selection method meets the Procurement Act 2023 requirements.

**Employers Guide** 

The future of human resources and organisational development <u>report</u>, published in November 2021, sets out a vision for the future of HR and OD in the NHS for 2030. The report's recommendations inform an ambitious programme of work with key actions for NHS England, ICS's, employing organisations, Chief People Officers, and People Professionals - that will deliver on the workforce challenges and aspirations set out in the NHS Long Term Plan, People Plan and delivering on the 'People Promise' for the people who work in the NHS.

Supporting and developing the NHS People Profession is a key enabler to delivering this vision and, within that, apprenticeships have an important part to play. The report requires that "Organisation and ICS Chief People Officers, or equivalent, ensure that all people professionals have professional development plans aligned to the delivery priorities and have access to apprenticeship programmes to enable CIPD accreditation at all stages of the career journey."

To deliver these aims, NHS England has been working especially closely with CIPD and Health Education England. This partnership working has established a new delivery model for

NHS People Profession Apprenticeships that supports building the capabilities described in our <u>People Profession Roadmap</u>

Following an extensive procurement and Supplier verification process, 8 Suppliers have been approved to deliver NHS People Profession Apprenticeships aligned to the Map.

# **Ordering Process**

Employers should send the Order (URN) Form at the following point in enrolment:

- For Funding Band >£10k courses, when (a) the individual learner has a place offered, or
   (b) for multiple learners, when a cohort start date is confirmed by the provider
- For Funding Band <£10k, when (a) for rolling starts you have the first starter and know an approximate annual number, or (b) for one off courses when the provider has offered a place for the apprentice.

Even if you already have a contract with a provider, please update Salisbury with an order form for new starts unless a rolling annual number has been given as above. Some procurements time expire and this allows us to check the correct contract in place, and will allow the provider to quote the correct order number on their documents.

Please do not sign provider contracts / service agreements if they send them direct. They must be in the NHS framework contract only.


For other enrolment paperwork, such as ESFA compliant cost breakdown, Training Plans, etc, providers may send these direct but must quote the correct order number for that cohort issued to them by Salisbury.

# Completing an Order

# **Employer Details**

The organisation employing the apprentice. The Organisation name **MUST** match exactly the HMRC PAYE name on the employers Digital Apprenticeship Service account – do not abbreviate or shorten.

The Signatory name should be the person with authority to sign a contract between the employer and the training provider.



# **Training Provider Details**

This is the company, college or university providing the apprenticeship for your learner – not the apprentices' employer, or someone providing a placement. The name MUST match exactly to the Providers registration on the ESFA APAR register – this can be checked prior to completing by asking your provider, or by checking at

The contact name should be the person who has confirmed your learner(s) have places. Please do not include the address.

# Completing the Apprenticeship details

**Standard number** – this will always start ST and is the Skills England allocated number for the apprenticeship. This can be checked either with your training provider, or at

# When to send an Order Form (URN request)

- **Order forms** can be downloaded from the Order Forms section on the FutureNHS Workspace <a href="https://future.nhs.uk/SalisburyApprenticeshipEF">https://future.nhs.uk/SalisburyApprenticeshipEF</a>
- Once the places are confirmed please do not send ahead of having a start month confirmed by your provider, or before eligibility checks have been completed. For cohorts (more than one learner) please send once your provider has confirmed they

have capacity, if numbers change following that the supplier reports that to us on their annual return. The numbers on Order Forms are not contractual, and we don't amend issued forms for changes in number of learners, or start dates after that indicated on the form.

- If you have never previously used the provider for the required standard then please send an order form
- If the Standard is Level 6 or Level 7 please always send an order form, even if you have enrolled learners previously under a framework contract
- If the Standard is above £10,000 funding band and even if you have enrolled learners previously, please send an order form.
- You DON'T need to send an order form if the standard's funding band is below £10k and it is a repeat enrolment i.e. you have a previous framework order covering that standard.

Given the legislative changes around both Apprenticeships/Levy Funds, and the delay to the Procurement Act, we have utilised the two year extension period in the framework to run for new call-offs up to 31st March, 2027. As this is an extension period to existing framework contracts, new suppliers will not be able to apply/join during the extension period. We reserve the right to end this extension period early, and replace with a new Framework ahead of 2027 should legislative landscape clarity allow. Employers may enter into contracts which extend beyond the lifetime of the Framework – no maximum is set by the Framework for the length of that subsequent contract. All subsequent contracts under the Framework are non-exclusive and do not form a minimum financial commitment by the Contracting Authority(ies).
